If customer fails to pay any indebtedness to Sunray when due, Sunray, at its option, may declare the entire balance of customer's account in default. Upon notice to customer, the entire balance of indebtedness shall become immediately due and payable. If it becomes necessary for Sunray to incur collection costs for any amount due under this agreement, customer promises to pay additional collection costs including reasonable attorney fees. If purchases will be exempt from sales tax, please attach a resale exemption certificate or other sales tax exemption certificate to this form. No purchases will be sales tax exempt until proper documentation has been provided. The laws of the State of Minnesota shall govern this agreement. Both parties hereto agree to bring suit only in a Minnesota state court located in Stearns County, MN. Violation of this covenant will bar recovery by Buyer in any other court.
